ELIGIBILITY TO VOTE

- D. A member is not entitled to vote at any General Meeting unless all monies due and payable by him/her to the Club in respect of the current financial year have been paid.
- E. Members are required to have been financial for a minimum period of three (3) months prior to the end of the financial year ending June 30th 2015 in order to be entitled to vote.

POSTAL VOTES

F. Members eligible to vote may apply for a postal vote. Applications for a postal vote must be lodged with the Secretary 14 days prior to the Annual General Meeting. Completed ballot papers must be returned in an envelope marked "Ballot Papers".
